

The Steve Barber, CPM® Scholarship  
Criteria and Procedures

## PURPOSE

Thanks to the generosity of Steve Barber, CPM® (who's long-standing service to the IREM® Oregon-Columbia River Chapter No. 29 ARM® program was the basis for this scholarship) Chapter No. 29 is proud to award scholarships to deserving real estate professionals.

## ADMINISTRATION AND AUTHORITY

The administration of this program is conducted by the IREM® Oregon-Columbia River Chapter No. 29 Scholarship Committee, which has complete and final authority and sole discretion to confer or revoke the Steve Barber, CPM® Scholarship Program. Scholarship awards shall be designated for ARM® designation CORE courses that are provided by the IREM® Oregon-Columbia River Chapter No. 29 IREM® and instructor courses. Applications will be evaluated on a first-come-first-served basis with awards given annually.

## ELIGIBILITY

To be eligible for the Steve Barber, CPM® Scholarship, the applicant must:

- Be a citizen of the United States
- Live or work in the jurisdiction of the IREM® Oregon-Columbia River Chapter No. 29
- Seek a career in the field of real estate management or be employed in the field of real estate management
- Complete the attached application form and submit the following:
  - A letter of support from the applicant's current or former employer which clearly states the achievements of the applicant and why the applicant deserves to be awarded the Steve Barber, CPM® Scholarship
  - Should the applicant not be employed, a reference letter from a *designated* IREM® member *and* a reference letter from a personal friend or relative who can confirm the applicants' intentions towards earning the ARM® designation and the applicants' commitment to seeking a career in real estate management
  - A letter from the applicant which clearly states the applicants' career objectives and how the scholarship will help the applicant reach those goals. The letter should include the applicants anticipated timeline for becoming an ARM®.

## SELECTION CRITERIA

Applicants will be reviewed according to the following criteria:

- Commitment to professional excellence in the real estate management industry
- Employer participation in education programs (does the employer reimburse employee for IREM® courses?)
- Strength of employer recommendation(s)
- Review of applicant's goals and anticipated timelines for gaining the ARM® designation
- Review and strength of non-employer recommendations
- Verification of living or working in the chapter's jurisdiction

## STIPULATIONS

The scholarship will be awarded to cover the cost of IREM® coursework which may include tuition and expenses for ARM® designation courses offered through the local IREM® Chapter No. 29, and instructor courses.

- Any information provided by the applicant shall be kept confidential. Only the IREM® Oregon-Columbia River Chapter No. 29 Scholarship Committee and/or Executive Council and/or IREM® staff will see this information
- The recipient must indicate in writing the course date and location for which he/she will be using the scholarship before funds are released
- Awards will be offered in the form of a reimbursement towards the local chapter tuition fee. Once the recipient has completed the ARM® Course (and regardless of whether the applicant passes or fails the course), the Scholarship Committee shall forward the reimbursement directly to the recipient (which could take up to 30-60 days). **Note:** Should the applicant fail to take the course in its entirety, the applicant will be ineligible for reimbursement).
- As funds allow, scholarships totaling \$250 each may be awarded annually (awards will be issued throughout the year [as funds allow] pursuant to current education course schedule on a first-come, first-served basis).

All applicants and recipients will agree to hold IREM® Oregon-Columbia River Chapter No. 29 Scholarship Committee, Executive Council, staff or employees, officers, members or agents harmless from any claims arising out of participation in or from application to this program.

## COMMITMENT TO PROPERTY MANAGEMENT EDUCATION

The scholarship award provides needed assistance to individuals pursuing their professional education in the field of residential real estate management. To the degree possible, scholarship recipients are encouraged (but not required) to acknowledge this assistance at some point in the future by making a contribution to The Steve Barber, CPM® Scholarship fund.
